- 2) Periodic monitoring and review of schemes, activities as well as the incidence of forest fire in the state.
- 3) To work out the modalities for monitoring of schemes, activities, and forest fire incidence.

The State Level Monitoring Committee shall meet at least once in 6 (Six) months and the monitoring and review report may be presented in the meeting of State Level Committee on Fire Prevention and State Level Sub-Committee on Fire Prevention headed by Hon'ble Chief Minister and Hon'ble Minister, Environment, Forests & Climate Change Deptt. respectively.
