**No.A.32015/7/2024-PCCF/61-63** : Walking test for the post of Forester and Forest Guard will be conducted on the date, time and venue mentioned below. Those applicants who were declared qualified in physical measurement vide No.A.32015/7/2024-PCCF/52 dt.09.08.2024 and No.A.32015/7/2024-PCCF/59-60 dt.20.08.2024 will have to appear for walking test.

**Date & time** : 3<sup>rd</sup> – 6<sup>th</sup> September, 2024 (6:30 AM & 7:30 AM)  
**Venue** : Starting point – Zero Point, Mualpui (World Bank Road)  
 Finishing point – Zero Point, Mualpui (World Bank Road)

As per the recruitment rule, applicants shall qualify for written examination only if they can walk a distance of-

- 25 km within 4 hours in case of male applicants.
- 14 km within 4 hours in case of female applicants.
- Those applicants who apply for both Forester & Forest Guard should report themselves at their allotted time to Forester post and need not to walk again for Forest Guard. Qualification for Forester will entail qualification for Forest Guard. Similarly, Disqualification for Forester will entail Disqualification for Forest Guard.
- Walking test will be done in 4 (four) phases {first three phases for Forester applicants (including those who applied both Forester & Forest Guard) and one last phase for those who apply Forest Guard only} as detailed below :

**\* Applicants are instructed to report themselves at the starting point at least 30 minutes prior to their starting time to complete formalities in time.**

- All applicants will be given their serial number printed and they should display it at the front side of their shirt while walking so that they are easily visible.
- There shall be check points (including starting point and finishing points) as shown below :

A. From Starting Point to Turning Point (First half).

Check Point No.	Distance from starting point (km)	Remarks
1	0	Starting point for all
2	3-4	For all
3	7	Turning Point for Female
4	8-9	For male only
5	12.5	Turning Point for Male

B. From Turning Point to Starting Point (Second half).

Check Point No.	Distance from starting point (km)	Remarks
1	3-4	For all
2	7	Finishing Point for Female
3	8-9	For male only
4	12.5	Finishing Point for Male


- All candidates should collect coupons from all the check points relevant to them.
- Those who report themselves within stipulated time in their respective finishing point counter with all the coupons from relevant check points will be declared qualified and the applicant should be informed accordingly. On the contrary, those who fail to reach within stipulated time or fail to submit all the coupons from relevant check points will be declared not qualified and the applicant should be informed accordingly.

- All applicants will be given additional 2 minutes each time they report themselves to the check points except the starting point and the finishing point.
- Applicants are advised to bring rain coat /umbrella/water/snacks, etc. as per their own requirement.
- Applicant will be disqualified on the spot if the practice of any unfair means is detected against him/her.
- Applicants are instructed to present at the place and time allotted to them only. No request for allowing delayed starting due to any reasons shall be entertained. The decision of the overall incharge of the Walking Test (CF, Northern Circle) shall be final in this regard.
