**NOTIFICATION**

Dated Aizawl, the 19<sup>th</sup> August, 2024

In compliance of the directions of Hon'ble Gauhati High Court Order dated 15.05.2024 in PIL No. 7/2021 (Indiscriminate Felling of Trees, Aizawl City, Aizawl- Vs.- State of Mizoram & 6 Ors.), the felling of trees from Reiek and Ailawng village area is hereby restricted till further orders are passed by the Hon'ble Gauhati High Court.

The persons having gardens within the Reiek and Ailawng village area are restricted from cutting all their trees on their lands. No tree shall be felled without the permission of the Divisional Forest Officer of the division concerned.

For felling of trees from these villages, the Environment, Forests & Climate Change Department's "Guidelines for felling of trees from non-forest areas issued in compliance of Hon'ble Supreme Court's Order dated 12.05.2001 in Writ Petition (C) No. 202 of 1995" published in the Mizoram Gazette Notification Issue No. 249 dated 09.08.2004 along with "Guidelines for felling and removal of trees from municipal areas of cities, towns, villages and along highways, railways and other government/public lands in Mizoram" published in the Mizoram Gazette Notification Issue No. 678 dated 08.11.2017 shall be strictly adhered to.
