Applications in the prescribed format are invited from interested candidates for appointment of Ombudsman in respect of Serhmun Village for redressal of grievances and disposal of complaints in connection with Judgement & Order dt.21.09.2022 passed in the Hon'ble Gauhati High Court in W.P (C) No.54/2021-Smt.Irene Zosangliani-vs-SoM & 4 ors.

The eligibility criteria viz. essential qualification, experience, sitting allowances etc. are as under:

Experience in working with people or community organization is a mandatory qualification. 2.Should not be a member of a recognized political party or a banned organization. Application is required to file a declaration to this effect along with application. 3.Must be physically active and capable of conducting Field tours, inspections and visits to remote rural location in the districts.

2. The tenure of the engagement will be 2 (two) years that may be extended twice by 1 (one) year each based on performance appraisal as till the incumbent attains the age of 68 years whichever is earlier. There shall be no re-appointment.

3. There shall be no written test/examination or interview and the selection will be based on the internal marking system evolved by the Selection Committee to rank persons in order of preference.

4. Preference may be given to persons residing in the same district or neighboring district so as to take advantage of his/her first hand knowledge about the district.

5. TA/DA/Transport on official duty as per Level-10 officers under Govt. of Mizoram will be admissible.
