This order will take effect from the date as shown against each staff.

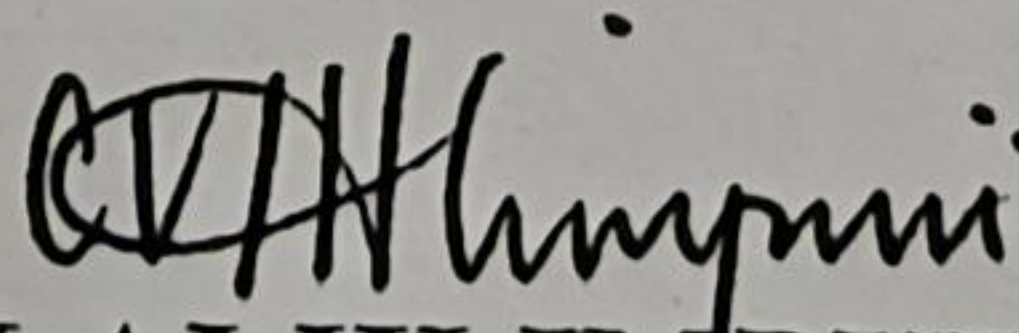
The financial upgradation under the MACPS, 2020 shall be purely personal to the employee and shall have no relevance to his/her seniority position.

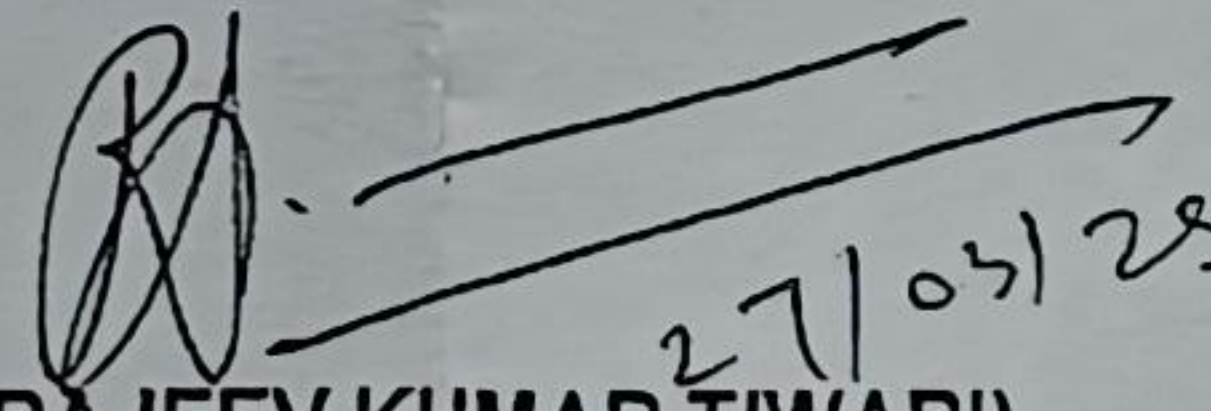

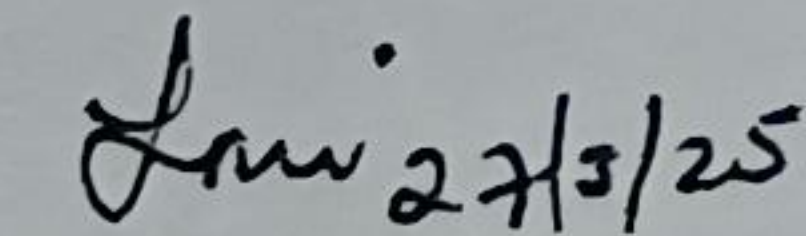

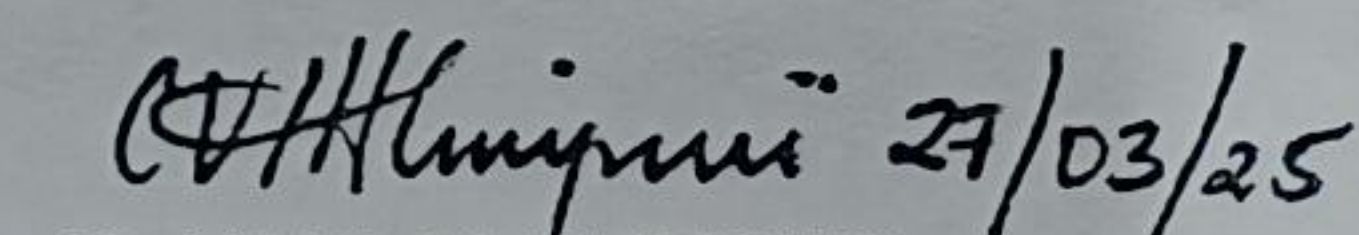
