- i. Lay down and/or approve rules and procedures for the functioning of the body and its Executive Committee, subject to the overarching objective and core Principles of State CAMPA.
- ii. Monitoring the progress of the utilization of funds released by the State CAMPA.
- iii. Approve the Annual Plan of Operation (APO) prepared by the Executive Committee.
- iv. Approve the Annual Reports and audited accounts of the State CAMPA.
- v. Ensure inter-departmental co-ordination.
- vi. Meet at least once in six months.
