- Monitoring the progress of the utilization of funds released by the State CAMPA.
- Approve the Annual Plan of Operation (APO) prepared by the Executive Committee.
- Approve the Annual Reports and audited accounts of the State CAMPA.
- Ensure inter-departmental co-ordination.
- Meet at least once in six months.
